Entry to ACP's Professional Examinations

CENTRES PLEASE NOTE: The following fees are based on a centre entering a minimum of 20 examination subjects per level, per session {for example, 5 candidates each entering 4 Certificate subjects} A centre may enter less than 20 examination subjects on payment of the balance of fees that make up the required minimum. Otherwise, entry should be postponed to a later date when a larger group may be entered. The 6-week deadline for entry to examinations must be strictly adhered to or Late Entry Fees paid on entry. An Unauthorised Entry Fee of £50.00 will additionally be charged per level in respect of any Candidate with an outstanding balance 14 working days before he/she sits an examination.

Certificate in Information Technology & Programming

First Entry to Certificate Examinations

Candidates pay a single fee for their first entry to all of the above examination components. This is referred to as their '**First-sitting Fee**'.

First Entry to Advanced Diploma Exams

Re-Entry to Failed Examination Subjects

Thereafter, any failed component(s) may be re-entered at a future examination session on payment of the 'Re-Sit Fee' identified below – per subject re-taken:

- **ISPN, ISAD or ISMg Re-Sit £43.00**
- **Re-submission of a Project £52.00**

IMPORTANT, PLEASE NOTE: All fees are payable in advance and are non-refundable and non-transferable to another student, subject or date. Students become liable for examination fees on booking, even if they do not subsequently sit the examination. Students should take local public holidays into account before entering examinations. Should a candidate be unable to attend an examination through illness, they will only be permitted to transfer their examination fees to the next available date on presentation of a Doctor's certificate relating to the period of absence. An administrative charge of £15.00 per subject should accompany the Doctor's Certificate, on receipt of which a Credit will be raised on the student's account. ACP does not accept part-payment of fees or allow payment in instalments. The First-Sitting Fee is payable in FULL when entering examinations for the first time at a given level. A Student's Registration Fee and 1st year's Annual Subscription (see overleaf) are payable in advance of entry to their first examination and, thereafter, a Candidate may only sit an examination if his/her membership is current. Membership and Examination Fees are payable a minimum of 6 weeks in advance of the examination(s) to be taken. A non-discretionary 'Late Entry Fee' of £40.00 per level entered per Candidate will automatically be applied to any Membership/Examination Entry received after the entry deadline shown on ACP's Examinations Calendar. This will apply to any outstanding part-paid fees including Membership which falls due during/before the examination week.. Those unwilling to pay a 'Late Entry Fee' should postpone their entry to a subsequent examination date. The First-Sitting Fee entitles a student to sit each of the three written examination papers at the chosen level, on one occasion and only on the specific date booked. It further allows the recording of a Student's overall performance in their Project(s) and/or Coursework (as applicable). Students are advised to note, however, that strict parameters exist with regard to Project and/or Coursework submission dates to allow for moderation and inclusion with results. Training centres who fail to meet the 4-week post-examination deadline will be charged, and may pass onto Students, a maximum penalty of £45.00 per level, per session for late Project(s) and/or Coursework. The submission of a second Project or Coursework mark attracts a second fee.
